CAAF CGIL Lombardy offers financial advice and support in navigating the system for citizens, workers, pensioners and families. It acts as an intermediary between citizens and the administration, to ensure that everybody's rights are respected and acted upon.

730 form

CAAF CGIL will fill in the 730 tax form for you, certify its correct compilation and provide insurance coverage for calculation errors. Special rates are available for CGIL members.

SPECIAL NEEDS ADMINISTRATOR

Assistance in preparing applications for the appointment of a special needs administrator and management of ongoing accounts and periodic reporting.

This service is aimed at all people who, due to either a physical or a mental impairment, find it even temporarily impossible to look after their own interests and don't have full autonomy in their everyday lives.

HOME-HELPS AND CAREGIVERS

The Home-help and Caregiver desk was created to provide families with all the assistance needed to manage the working relationship with cleaning ladies, family assistants, babysitters and housekeepers, guaranteeing to the employer correctness, accuracy and professionalism in compliance with employment law and to the domestic worker all the rights and protections recognized by the National Collective Labor Contract.

ICRIC - ICLAV - ACCAS/PS

For those who receive an attendance allowance, a monthly cheque for invalidity or the state pension, in our offices we offer specific help with the completion of ICRIS - ICLAV - ACCAS/PS, which is entirely FREE OF CHARGE, plus the electronic transmission of the files to INPS.

IMU

In our offices there is a special service that provides assistance for the calculation and completion of the IMU (property tax) and TASI (tax on general city services) payment forms.

ISEE

ISEE is a tool that allows access to subsidized social benefits or to public services at reduced rates through means testing of the applicant and his/her own family unit.

IVA (VAT)

An ad hoc service is set up in all the branches of CAAF CGIL to provide assistance and advice for the administrative management of VAT and all the obligations related to bookkeeping. Choose to have tax assistance from professionals like you.

RED

The RED is a statement, required by law, that must be presented by pensioners who use certain services. The rights to these services and the level of support offered, it's dependant upon the citizen's income.

REDDITI (INCOMES)

Compilation Service of the INCOME model, with insurance coverage related to the penalties for any errors deriving from the compilation.

INHERITANCE

A special service is set up at the CAAF CGIL offices to provide assistance and advice for inheritance issues with advantageous rates.

OTHER SERVICES

INTERNET SERVICES: the services offered by CAAF through the connection that it has with the offices of the Regional Agency and with the AGENZIA DELLE ENTRATE (Tax Office) with INPS.

TAX LITIGATION: assistance to citizens who have received official reminders or tax files from the AGENZIA DELLE ENTRATE (Tax Office) or Local Bodies, to compile applications or appeals to present to the Territorial Offices or to the Tax Commissions.

RAVVEDIMENTO (Acknowledgement of errors): assistance to citizens who intend to remedy errors and/or omissions in their annual Tax Return which entail the imposition of sanctions by the Tax Office.

MAIN DEADLINES:

- Form 730: July 23rd
- Income Form (formerly known as UNICO): October 31st
- IMU - TASI: 1st instalment June 16th
2^o instalment December 16th
- INHERITANCE STATEMENT: within 12 months from the death date
